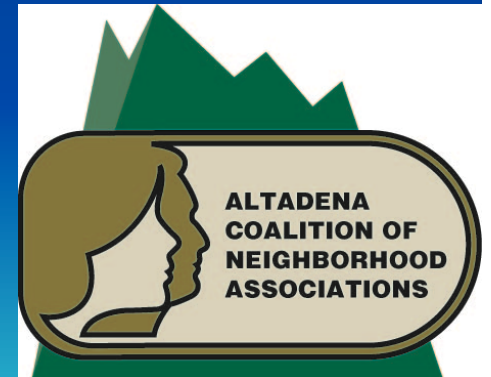

Would you consider moving from the "block" plan, which is not effective in most cases, so a broader "several blocks" plan?
