- Operate a full-service animal shelter providing animal control in 11 contract cities



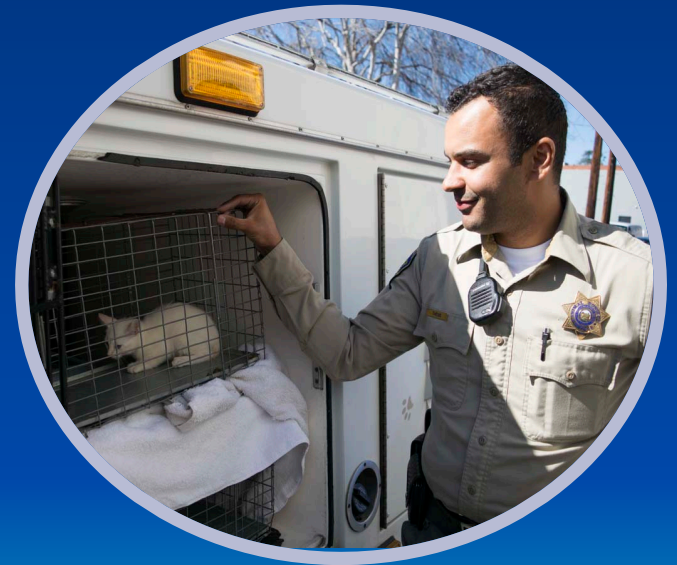

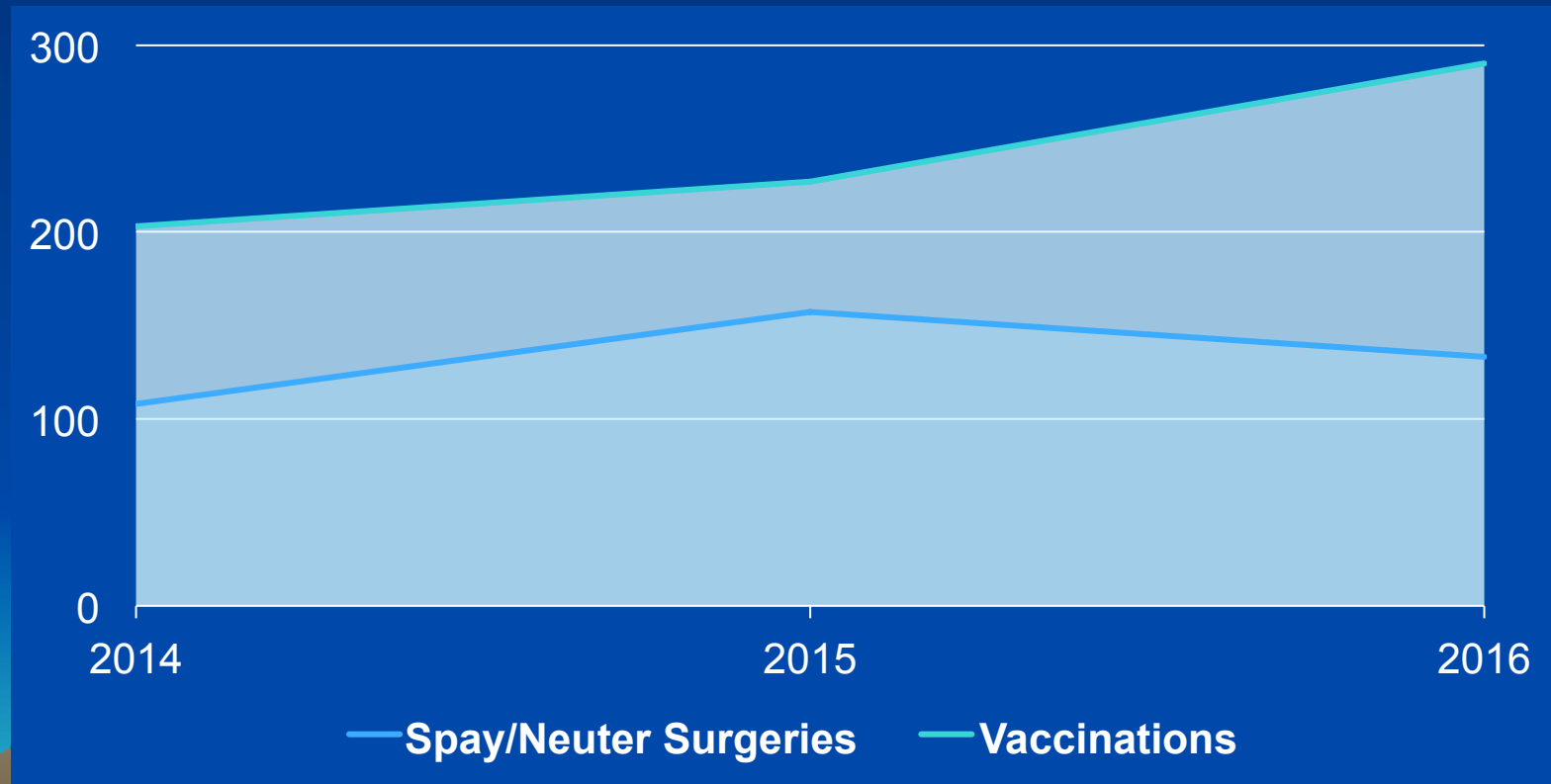
Animal Control Contract

- We also field calls related to animal control



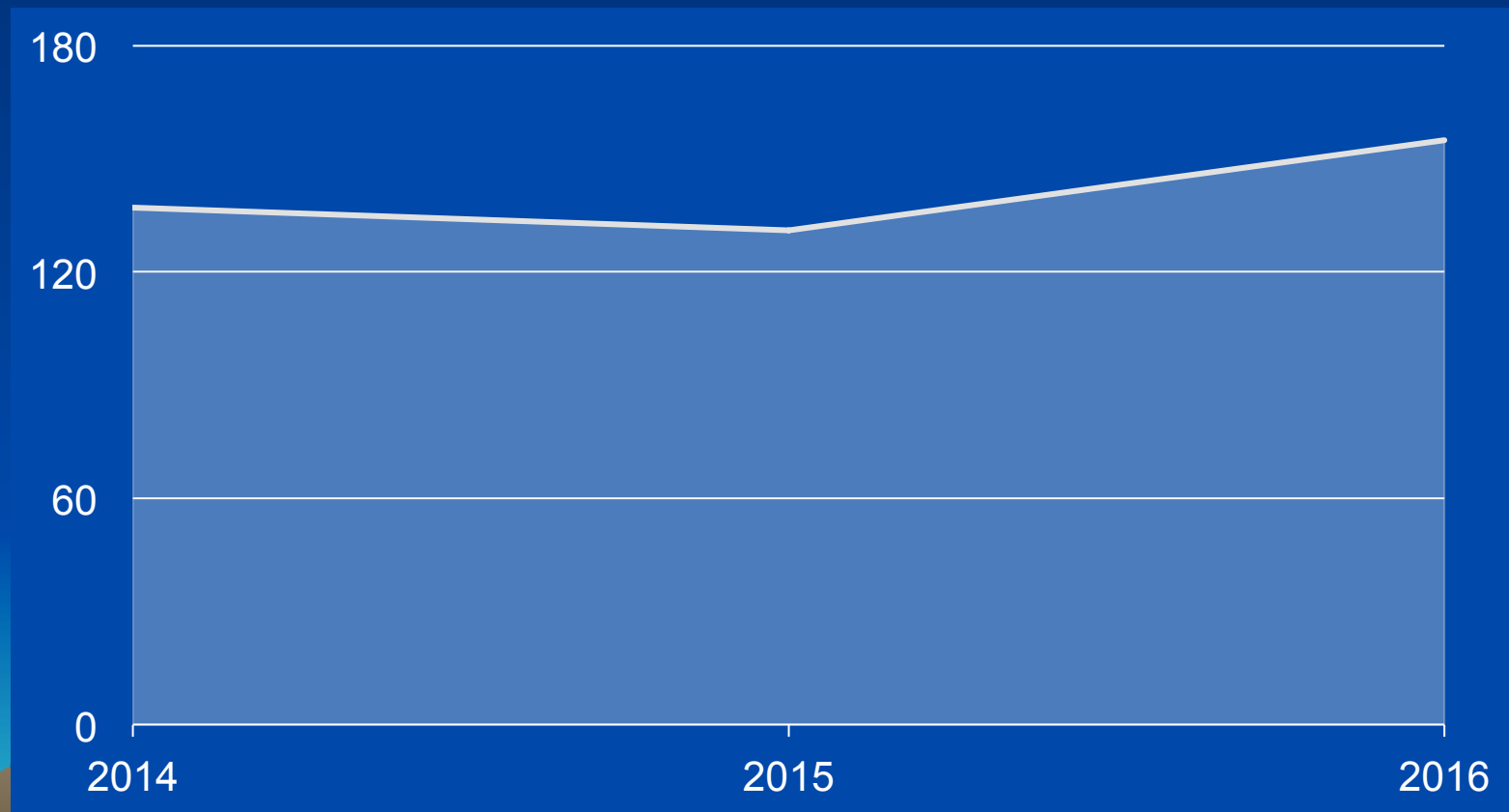
Spay/Neuter and Vaccinations for Altadena Residents

Total: 423 adopters from 2014-2016



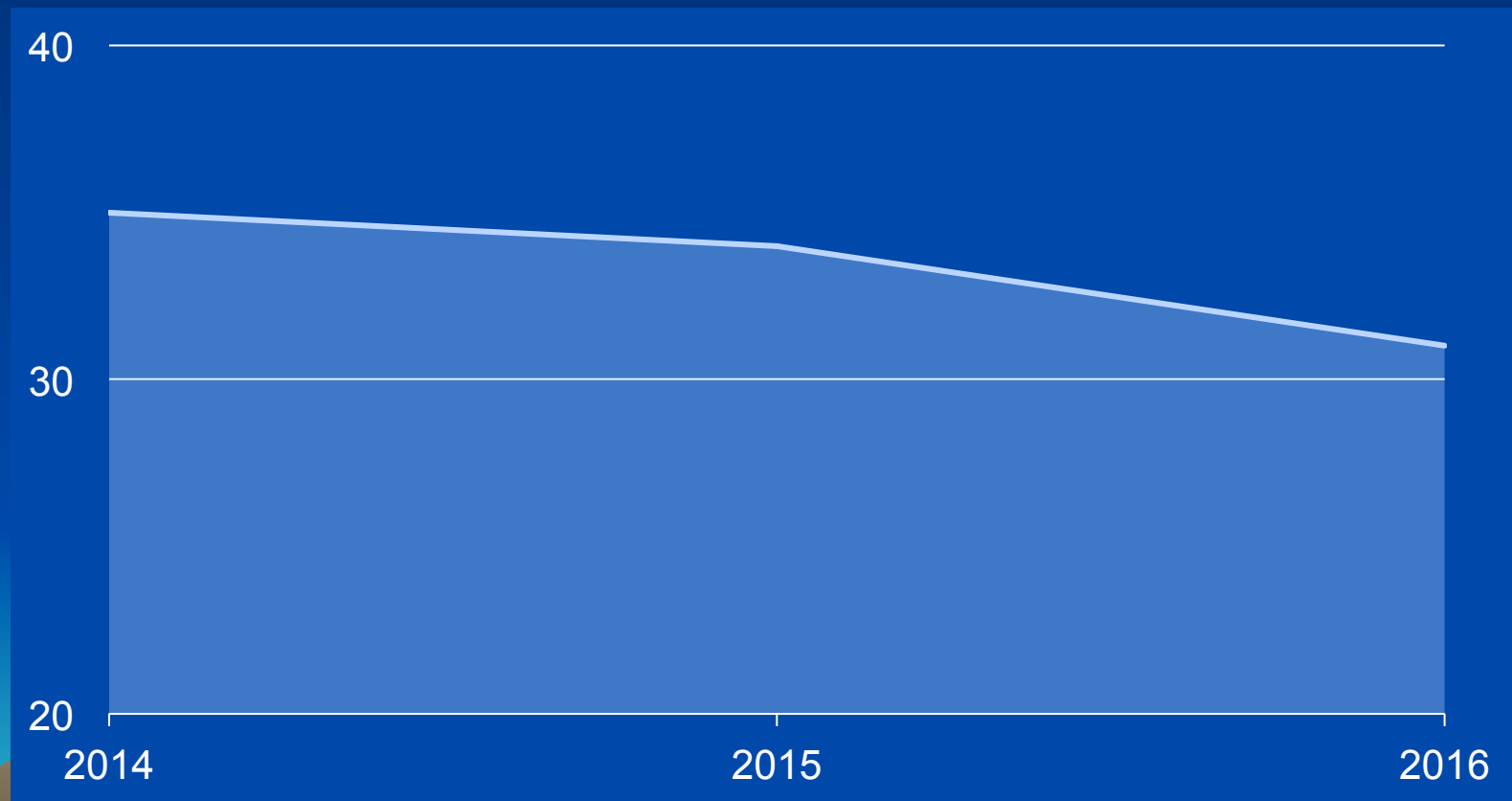
Dog Training Clients from Altadena

Total: 94 clients from 2015-2016



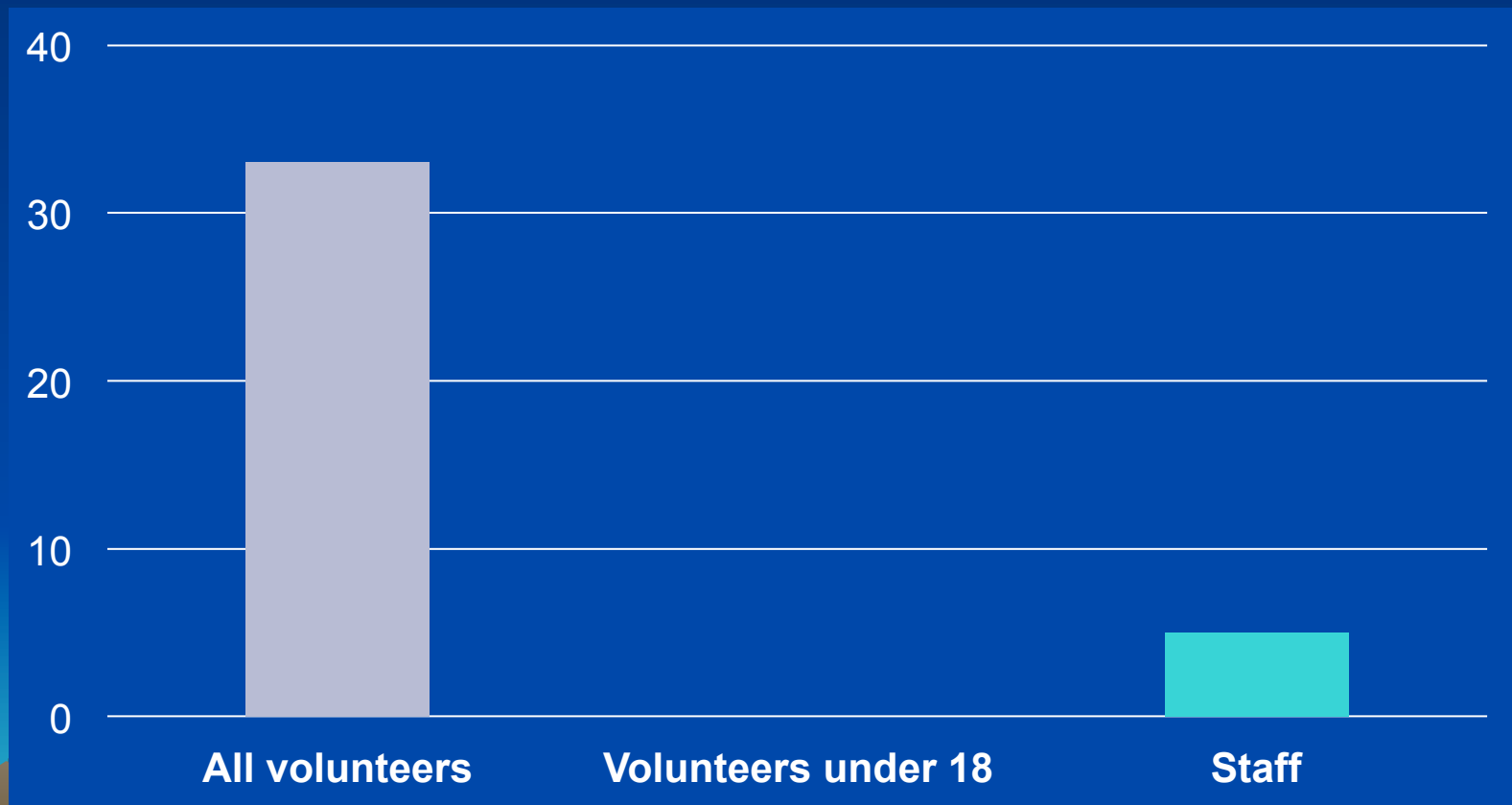
Boarding Clients from Altadena

Total: 100 clients from 2014-2016



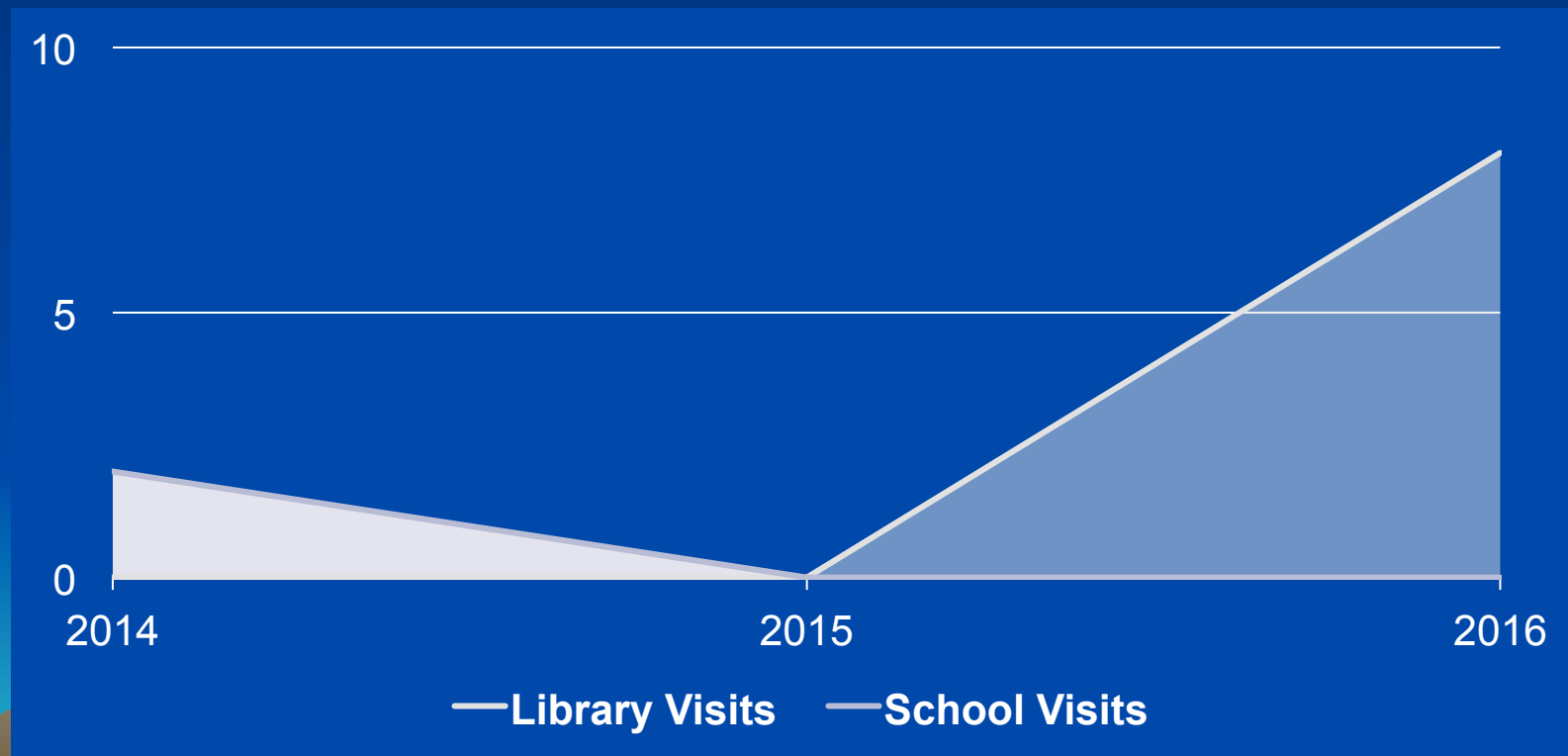
PHS Volunteers and Staff from Altadena

Total: 33 Volunteers and 5 Staff



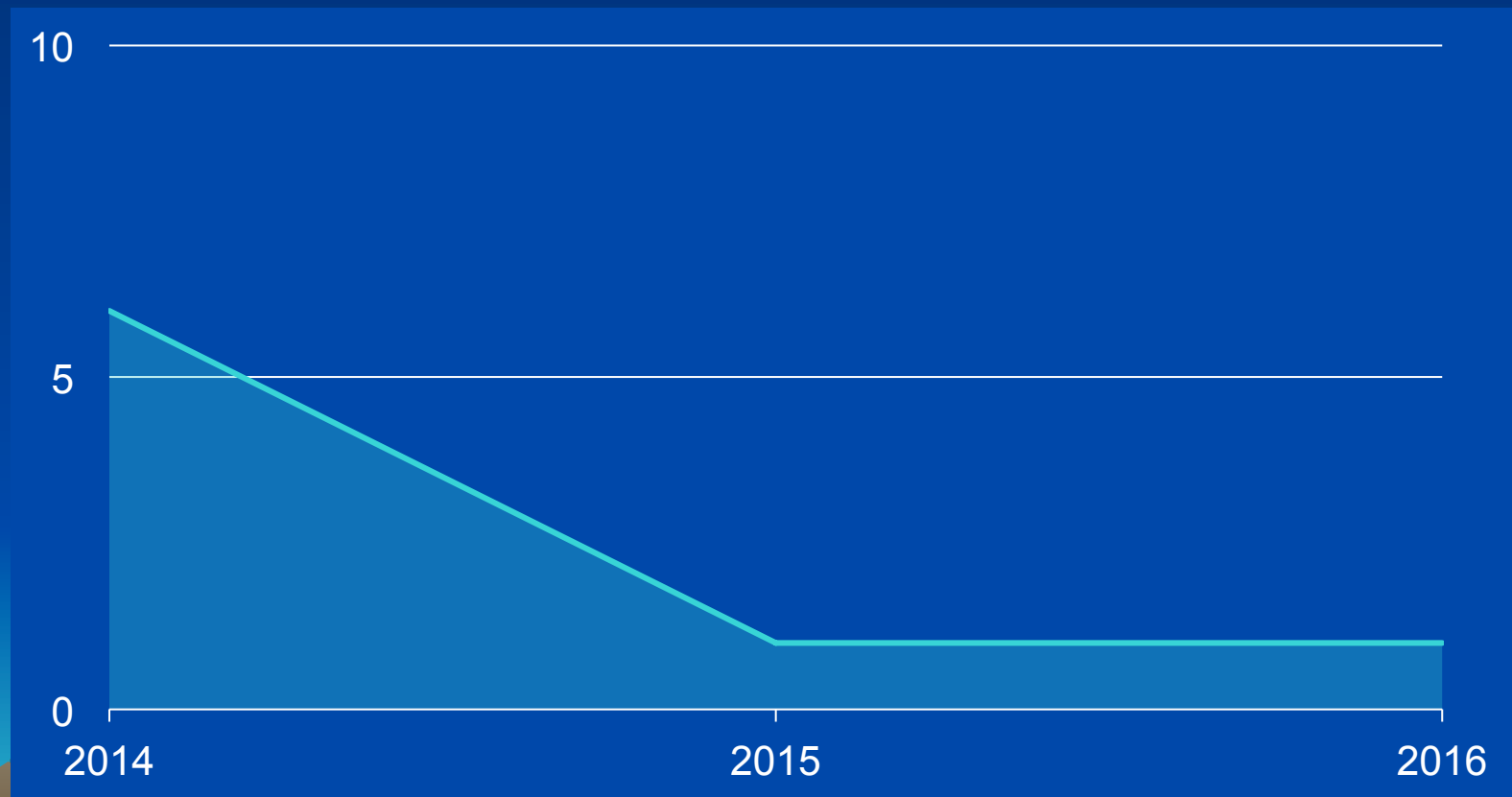
Visits to Altadena Libraries and Schools

Total: 8 library visits and 2 school visits from 2014-2016



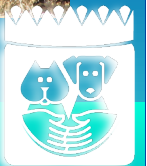
Waggin' Visits to Altadena

Total: 8 visits from 2014-2016



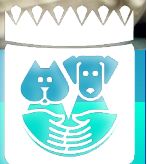
Wildlife Management

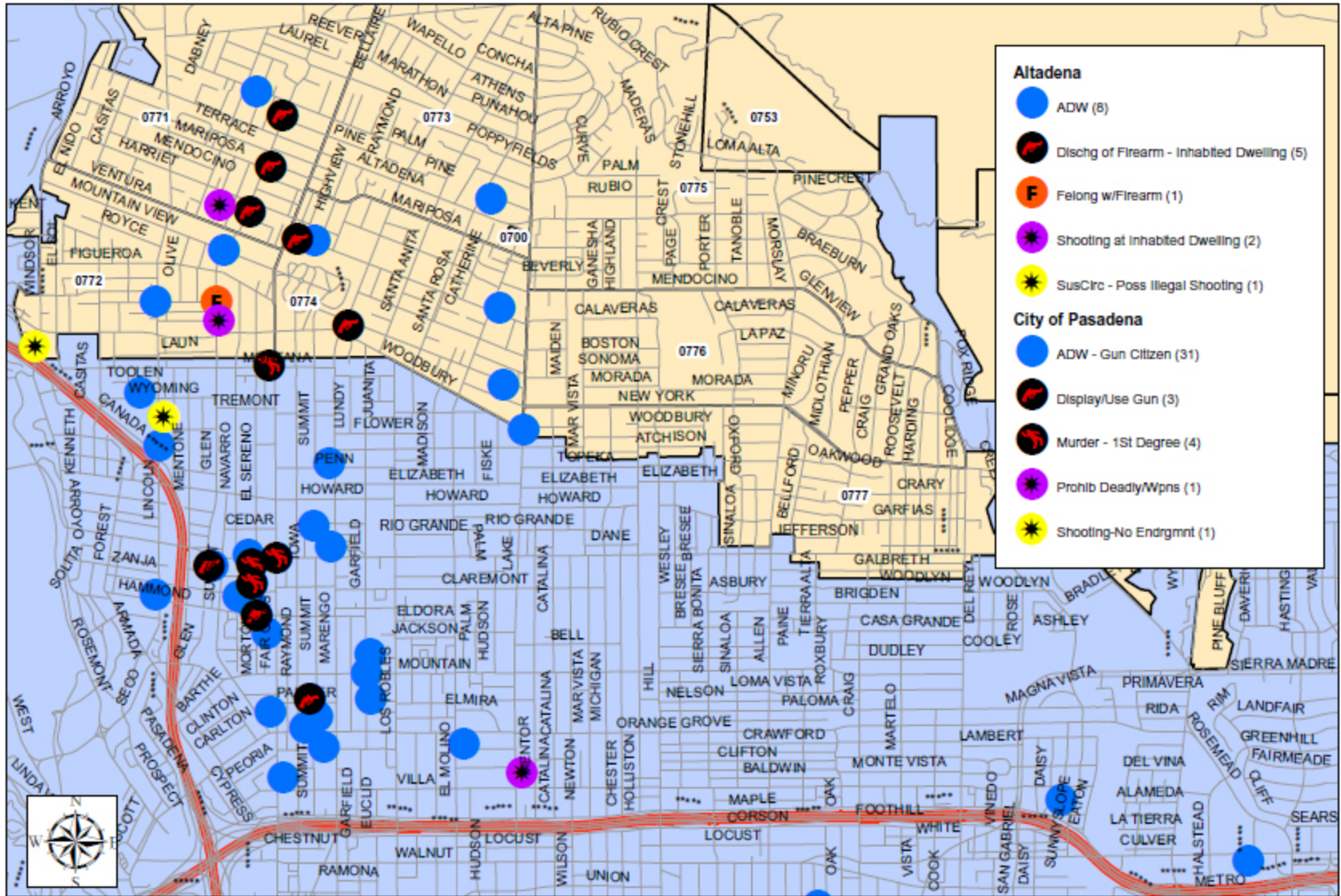

Violence Reduction Effort (VRE) Update

- **December 20, 2016** - LASD deputies investigated a shooting in Altadena. The victim was an alleged street gang member and was hit by gunfire.
- **December 22, 2016** - Pasadena Police officers responded to the 1100 block of Fair Oaks regarding reports of shots fired. On arrival officers located victim suffering from several gunshot wounds. The victim did not survive the shooting.
- **December 23, 2016** - LASD deputies investigated a shooting in Altadena involving a suspected local Pasadena gang member who happened to be in Altadena at the time of the shooting. The victim was not injured.
- **December 27, 2016** - LASD deputies investigated a shooting in Altadena where the suspect(s) fired into a residence of an alleged Pasadena gang member who resides in Altadena. There were no injuries as a result of this incident.

Violence Reduction Effort (VRE) Update

- **January 6, 2017** - Pasadena Police officers responded to the 100 block of W. Claremont Street regarding a report of shots fired. On arrival PPD officers discovered four people had been shot. Two victims died as a result of the shooting. Two additional victims (male and female) were hit by gunfire. Our investigating is ongoing.
- **January 7, 2017** - LASD deputies investigated a shooting, which occurred in Duarte. Two victims believed to be gang members, were hit by gunfire.
- **January 7, 2017** - The Pasadena Police Department implemented the 2017 Violence Reduction effort, which consisted of extra patrols and collaborative efforts with the Los Angeles County Sheriff's Department, Temple and Altadena Stations.

Violence Reduction Effort (VRE) Update

- **January 7, 2017** at about 1:40 p.m. - SES Gang officers stopped a vehicle occupied by two alleged Pasadena gang members. Following a brief foot pursuit, an armed suspect was arrested without incident. Ultimately, PPD officers arrested three suspects and recovered two loaded guns.
- **January 7, 2017**, at about 4:45 p.m. - Pasadena Police officers responded to Claremont Street and Fair Oaks Avenue regarding a shooting victim. The victim, believed to be a Pasadena gang member, suffered a non-life threatening wound. Our investigation is ongoing.
- **January 8, 2017**, at about 7:10 p.m. - Pasadena gang officers assigned to the VRE (Violence Reduction Effort) stopped a vehicle in the 400 block of north Los Robles Avenue. Three suspects were arrested without incident and officers recovered two loaded firearms, including an Assault Rifle. The suspects were booked for various charges.

Violence Reduction Effort (VRE) Update

- **On January 9, 2017** at 2:11 a.m. - Pasadena Police officers assigned to the VRE (Violence Reduction Effort) stopped a vehicle in the parking lot of Kings Villages. Officers recovered five loaded guns, including an Assault Rifle. Four suspects were arrested without incident.
- **January 13, 2017** - a shooting took place in the City of Pomona which claimed the lives of two male black adults. The two victims are alleged to be gang members or gang associates. Early information revealed that the suspect(s) involved in this double homicide are believed to be gang members.
- **January 15, 2017** at about 8:30 a.m. - LASD Deputies investigated a shooting in the City of Duarte at a known gang location. A male black adult sustained a non-life threatening gunshot wound. Based on the information, it is believed that the suspects are African American and possible gang members.

Violence Reduction Effort (VRE) Update

- **January 16th, 2017**, at about 2:50 a.m. - A shooting took place in the 800 block of N. Garfield Ave. Numerous shots were fired from a semi-auto hand gun and an assault rifle. A female Hispanic sustained a non-life threatening gunshot wound and a second female was injured by glass fragmentation. It is believed that two male black subjects (possibly gang members) were the intended targets of this shooting. The suspects (shooters) are described as male African Americans.
- **In January**, as result of the surge in violence, the Pasadena Police Department arrested 10 suspects and 9 loaded firearms (of which two were assault rifles)
- **Since February**, the Pasadena Police Department has continued the Violence Reduction Effort (VRE) program to keep the community safe with the extraordinary efforts of patrol officers and specialized units
- In February and March, the level of violent incidents subsided; however, Pasadena Police Officer seized an additional six firearms from suspects

Violence Reduction Effort (VRE) Update

- Following the department's intervention and prevention service model, Pasadena Police Community Services officers and employees responded to the affected areas of the recent homicides and the shootings. Officers talked with residents and distributed flyers requesting the public to call the police with information that may be helpful to solving the murders and shootings
- The PPD has continued to work with the Los Angeles County Sheriff's Department, Temple City and Altadena Stations to attempt to identify the suspects(s) responsible for the double homicide, related shootings in Pasadena, Altadena and Duarte
- PPD has also continued its community outreach efforts to keep community members informed about the recent violence
